HOSPITAL PREPAREDNESS PROGRAM

The Assistant Secretary for Preparedness and Response (ASPR) is the funding agency for Montana's Regional Healthcare Coalitions. ASPR's Hospital Preparedness Program enables health care delivery systems to save lives during emergencies and disaster events that exceed day-to-day capacity and capability of existing health and emergency systems. HPP is the only source of federal funding for health care delivery system readiness intended to:

- Improve patient outcomes
- Minimize the need for federal supplemental state resources during emergencies
- Enable rapid recovery.

Foundation for Health Care and Medical Readiness

The community's health care organizations and other stakeholders - coordinated through a sustainable Health Care Coalition - have strong relationships, identify hazards and risks (HVA), and prioritize and address gaps through planning (EOP), training, exercising, and managing resources (budget).

EMResource

EMResource equips those involved in healthcare and emergency response with practical, convenient and holistic operational view of area, regional and enterprise-wide resources these range from individual beds to entire facilities.

When tragedies occur, healthcare facilities, EMS agencies, and government entities rely on EMResource for situational awareness. The solution offers the tools needed to monitor and query current asset statuses and bed availability, and alert and engage constituents, partners and coalition members in both daily and response operations.

Electronics ICS (eICS)

Healthcare organizations such as hospitals, healthcare coalitions, long-term care facilities, home health agencies and hospice services can use eICS to streamline management workflows, improve response times and decrease the impact of operational disruptions.

Adapting templates, assigning positions, and sharing documents in advance provide incident participants with clear knowledge of their roles and responsibilities, making it easier to take action when the moment arises.
