



OPERATIONS

Study: Layered cotton face coverings may best slow COVID-19 in public. Three of the five most effective cloth face coverings tested by the National Institute of Standards and Technology were 100% cotton and had a visible raised fiber or nap, such as found on flannels, the agency <u>announced</u> yesterday. The researchers tested how well 32 natural and synthetic fabrics filtered particles similar in size to the virus that causes COVID-19; none of them came close to the efficiency of N95 masks. The CDC <u>recommends</u> people wear cloth face coverings to help protect others in public settings where social distancing is difficult.

FDA issues EUAs for COVID-19 tests, resuscitator and ventilator. The FDA last week authorized the emergency use of two COVID-19 molecular diagnostic tests. The tests from <u>Inform Diagnostics Inc.</u> and <u>Diagnostic Solutions Laboratory LLC</u> detect in respiratory specimens nucleic acid from SARS-CoV-2, the virus that causes COVID-19. FDA also recently added an emergency resuscitator and a ventilator to its ventilator <u>EUA list.</u>

PLANNING

Continue resource reporting to State. The following reporting requirements are in effect. For questions, please contact your <u>Regional Coordinator</u>.

- Hospitals: Continue reporting to Juvare/EMResource as follows:
 - · Daily: Bed and ventilator counts

- · Weekly (every Friday): PPE
- Following treatment of COVID-19 patient(s): COVID-19 patient data, as directed by public health officials
- <u>Long-Term Care Facilities:</u> Bed and PPE counts to be reported weekly on Fridays. Regional Coordinators will email out a survey link weekly to each facility for bed and PPE data.

LOGISTICS

Streamlined sign-up process for Battelle mask decontamination program.

Battelle and Montana DES have simplified the sign-up process for participation in the Critical Care Decontamination System (CCDS) for NIOSH-approved N95 masks. Get started with the <u>4-step sign-up process</u>.

Submit PPE needs to DES coordinator in order to ensure allocation. In order to receive an allocation of emergency PPE, healthcare organizations MUST <u>submit needs to their local DES coordinator</u>.

FINANCE & ADMINISTRATION

AHA report: Hospital financial losses from COVID-19 expected to top \$323 billion in 2020. An AHA report released today finds that the financial strain facing hospitals and health systems due to COVID-19 will continue through at least 2020, with total losses expected to be at least \$323 billion in 2020. The report estimates an additional minimum of \$120.5 billion in financial losses, due in large part to lower patient volumes, from July 2020 through December 2020, or an average of \$20.1 billion per month. These estimates are in addition to the \$202.6 billion in losses the AHA estimated between March 2020 and June 2020 in a report released last month.

Today's report also says the projected losses still may underrepresent the full financial losses hospitals will face in 2020, as the analysis does not account for currently increasing case rates in certain states, or potential subsequent surges of the pandemic occurring later this year.
