

THE 2023 LEGISLATIVE SESSION BROUGHT SIGNIFICANT CHANGES TO THE LEGISLATIVE PROCESS. The session was the first meeting of lawmakers following the peak of the COVID-19 pandemic. Legislators arrived in Helena amid the news of nursing home closures, extreme and expensive staffing shortages across most treatment settings and the ongoing behavioral health crisis. The public image of hospitals was repeatedly raised by lawmakers on both sides of the aisle. Hospitals were perceived to be financially comfortable, hoarding significant cash reserves while continuing a never-ending investment in new structures, all while facing a body skeptical of the investment in community benefits and of hospitals putting forth an effort to rein in healthcare costs.

Meanwhile, the state was enjoying a historical budget surplus and had plans to balance tax reductions and rebates with much needed new investment in Medicaid provider rates and other state infrastructure. Developing community mental health services seemed at times to command center stage as the legislature contemplated spending \$300 million over the next two years on a still-to-be determined mental health delivery system. Legislators enacted several bills that, on one hand, increased parental rights for health services provided to children, while on the other stripped parental rights completely. There will be impacts on the practice of medicine due to a series of measures best described as related to the culture wars.

We've emerged from this session having achieved all of the goals that MHA members established prior to the session. Those goals included protecting Medicaid expansion and the integrity of the Hospital Utilization Fee (HUF) structure; obtaining a modest increase in Medicaid provider rates; and meeting the State's desire to increase accountability and transparency for community benefit spending. Additionally, we were successful in beating back new legislation that would have increased the costly and unnecessary administrative burden on healthcare facilities. These accomplishments were secured thanks to the engagement of the members in the political process coupled with the hard work put forward by MHA staff and the hospital



lobbyist group. Together, we successfully weathered one of the more challenging sessions for the healthcare provider community in recent years.

As the dust settles and the impacts of legislation enacted in this session are better analyzed, we have our work cut out for us. Serious and deliberate work is needed to address our "image problem" while aligning our members and those legislators supportive of our mission to prepare for 2025.

## HB 17 PROVIDE FOR IMPLEMENTATION OF CERTIFIED COMMUNITY BEHAVIORAL HEALTH CLINIC MODEL

HB 17 would require the Montana Department of Public Health and Human Services (DPHHS) to implement the Certified Community Behavioral Health Clinic model and require payment by the Medicaid program. The program would have been required to be implemented no later than July 1, 2025.

## **HB 312** PROVIDE FOR RURAL EMERGENCY HOSPITAL DESIGNATION

HB 312 would allow Montana DPHHS to license a hospital as a Rural Emergency Hospital (REH) under new federal regulations. The transition to REH status generally would be the last effort to retain healthcare services in a community. If the community hospital chooses to become a REH, the community will continue to have access to an emergency room and other outpatient services while closure would eliminate nearly all medical services for that community.

## HB 872 PROVIDE FUNDING FOR BEHAVIORAL HEALTH SYSTEM FOR FUTURE GENERATIONS

HB 872 contributes funding into a special account to fund a redesign of behavioral health services in Montana. The bill creates a commission of legislators, DPHHS and subject matter experts to overhaul the program in Montana while creating reporting and performance measures.

## **SB 112** REVISE PHARMACIST PRESCRIBING AUTHORITY

SB 112 is an act to revise pharmacist prescribing authority to allow the prescribing of certain drugs or devices under limited circumstances.

## GENERAL APPROPRIATIONS ACT

The governor's budget proposal forms the basis for HB 2, the general funding bill for all state government functions for the next two years. Governor Gianforte's budget proposed large increases for Medicaid provider rates based on the 2022 Medicaid Provider Rate Study conducted by Guidehouse and commissioned by Montana DPHHS with funding appropriated by the 2021 Montana Legislature. There was also a large focus on addressing the behavioral health issues that exist in Montana.

Medicaid rates for hospital inpatient and outpatient services will increase 4% each of the next two state fiscal years (SFY 2024 and SFY 2025); physician rates will increase in line with the medical CPI (currently projected at 4.2% for SFY 2024); the rate for primary care services will increase 4% each of the next two state fiscal years; and nursing home rates are projected to increase from an average of \$212 per day in 2023 to at or near the \$278 per day rate recommended in the Provider Rate Study. There was also a major investment into behavioral health reimbursement rates.

## HB 649 IMPLEMENT RATES FROM PROVIDER RATE STUDY

HB 649 would fully implement the Medicaid provider rate increases outlined in the 2022 Medicaid Provider Rate Study. The Section B (Health and Human Services) budget did not fund the programs included in the rate study up to the recommended rates. Those providers include nursing homes, behavioral health, disability services and other smaller programs.

A additional \$48 million in state general funds would be required to close the gap between the rates approved in the Section B budget and those recommended in the Provider Rate Study. Total funds (including federal funds) would be \$140 million annually. The bill was amended and included an appropriation of \$5 million in state general funds and \$9 million in federal funds for a total value of \$14 million.

## AUTHORIZE TRANSFERS AND OTHER NECESSARY MEASURE TO IMPLEMENT HB 2 SECTION B

HB 917 is a companion bill to HB 2 and would implement policy direction for the funding outlined in the budget bill. The bill requires additional Montana DPHHS reporting on state-owned healthcare facilities regarding budget and staffing needs. In addition, DPHHS must include additional reporting on the Temporary Assistance for Needy Families (TANF) to the interim committee.

## HB 29 REVISE LAWS RELATED TO INVOLUNTARY COMMITMENT OF PEOPLE WITH DEMENTIA OR TBI

HB 29 revises the criteria for institutional commitment for individuals with a primary diagnosis of Alzheimer's disease, other forms of dementia or traumatic brain injury. The bill ends involuntary commitment of certain individuals after June 30, 2025.

HB 29 outlines the criteria for certain Montana State Hospital geriatric patients who should be given first priority for transfer to nursing homes. The bill also establishes a temporary Transition Review Committee with the purpose of developing and implementing a plan to prepare for the end of involuntary commitment of many individuals with a primary diagnosis of Alzheimer's disease, other forms of dementia or traumatic brain injury. The bill also calls for the development and implementation of a plan to ensure the availability of community-based services for these individuals.

## HB 79 CREATE SEXUAL ASSAULT RESPONSE NETWORK PROGRAM AND COMMITTEE

Requested by the Montana Department of Justice, HB 79 would create a sexual assault response network program within the Department of Justice. It also creates a sexual assault response team committee with assigned duties of adopting educational and clinical standards for sexual assault nurse examiners; developing statewide teleSANE partnerships; identifying and implementing a statewide forensic nurse platform for sexual assault nurse examiners to engage, mentor, share, and network among colleagues; and establishment of certain payment standards.

## **HB 154** REMOVE LICENSURE REQUIREMENT FOR MEDICATION AIDES

HB 154 originally would have removed the licensure of Medication Aides from the Board of Nursing under the Montana Department of Labor and Industry. After much input from the long-term care industry, the bill was amended to continue the licensure but reduce work qualifications for Medication Aide II from 2 years to 1,000 hours and annual continuing education from 12 hours to 6 hours in pharmacology and medication administration.



## **HB 200** REVISE THE MONTANA SAFE HAVEN NEWBORN PROTECTION ACT

HB 200 clarifies that a newborn may be surrendered via a newborn safety device or by placing an emergency call. It also states in the act that parents may remain anonymous when surrendering their infant.

## **HB 313** PROVIDE FOR INDEPENDENT PRACTICE OF PHYSICIAN ASSISTANTS

HB 313 is a law providing for independent practice of physician assistants. It further clarifies that a physician assistant with fewer than 8,000 hours of postgraduate clinical experience shall practice medicine with a collaborative agreement between the physician assistant and one or more collaborating providers. A licensed physician assistant actively practicing for 8,000 hours prior to October 1, 2023 is exempt from the collaborative agreement requirement.

HB 645 PROHIBIT DONATIONS OF CERTAIN BLOOD AND BLOOD PRODUCTS

HB 645 would not allow a person to knowingly donate whole blood, plasma, blood products, blood derivatives, human tissue, organs, or bones containing gene-altering proteins, nanoparticles, high-count spike proteins from Long COVID, or other isolates introduced by mRNA or DNA vaccines, mRNA or DNA chemotherapies, or other novel mRNA or DNA pharmaceutical biotechnologies.

HB 645 also prohibited healthcare providers from knowingly using, receiving, accepting, shipping, transferring or administering blood products, blood derivatives, human tissue, organs or bones containing the items noted above.

## **SB 99** PROVIDE FOR A YOUTH HEALTH PROTECTION ACT

HB 99 is an act prohibiting certain medical and surgical treatments to treat minors with gender dysphoria. HB 99 would also prohibit public funds, programs, property and employees from being used for medical and surgical treatment of gender dysphoria. Healthcare professionals who violate this law would be found to have committed professional misconduct, which would result in the suspension of their ability to administer healthcare or practice medicine for at least one year.

The Governor amended the bill to include treatment for children requiring a necessary medical procedure due to a medically verifiable disorder of sex development, or a cancer diagnosis requiring the surgical removal of reproductive organs. The Governor's amendments were approved by both chambers.

## SB 284 REQUIRING REPORT OF DRUGS TAKEN BY OR PRESCRIBED TO A VICTIM OF SUICIDE

SB 284 revises laws related to reporting of drugs taken by or prescribed to individuals whose deaths are ruled to be suicide. This would include a list of all controlled substances dispensed to each person whose death was ruled to be a suicide. This also requires coroners to report available toxicology results for individuals who completed suicide requiring a report of toxicology and controlled substance information in deaths ruled to be a suicide. Montana DPHHS would collect the required reporting data and report to the Montana Legislature.

## SB 422 EXPAND ELIGIBILITY FOR THE RIGHT TO TRY ACT

SB 422 would expand the Right to Try language and would allow a non-terminal patient to access experimental medications if they have considered all other treatment options; received a recommendation from their provider; and consented to the use of the drug, product or device.

## HB 45 PROVIDE OVERSIGHT AND STANDARD FOR COMMUNITY BENEFITS/CHARITY CARE

HB 45 was the bill from Montana DPHHS to address the concerns raised in the 2020 Legislative Audit Division report regarding the Department's oversight of nonprofit hospitals. The audit was critical of the Department. In response, the Department proposed this bill to implement new rules and receive new reports from hospitals regarding community benefit. MHA worked with DPHHS and the sponsor to agree on language that did not increase unnecessary administrative burden on hospitals but would provide DPHHS with the necessary information for them to move forward with administrative rules.

The bill allows the Department to create new administrative rules, but requires the Department to align rules with existing federal regulations and permit hospitals the flexibility to tailor their community benefit activities to the unique needs and available resources of their local communities.

## REVISE LAWS RELATED TO PROFESSIONAL AND OCCUPATIONAL LICENSURE HB 152 WAXCH

HB 152 was at the request of the Gianforte Administration as a part of the Red Tape Relief Project in partnership with the Montana Department of Labor and Industry. This bill changed significantly from a 400-page bill to a five-page bill as it worked its way through from the House to the Senate.

In its amended form, it would support a temporary license for a military spouse to practice a profession or occupation regulated by the Department. It also allows each board and program, upon presentation of satisfactory evidence by an applicant for licensure, to accept relevant education, training or service completed in the armed forces or reserves of the United States, the National Guard, military reserves or naval militia of a state toward the gualifications of licensure.

## HB 303 IMPLEMENT MEDICAL ETHICS AND DIVERSITY ACT

HB 303 is an act providing protections for the actions of a medical practitioner, healthcare institution, and healthcare payer based on conscience. The bill defines "conscience" as the ethical, moral or religious beliefs held by these persons or institutions. The bill would also provide protections for objecting to participate in healthcare services based on conscience.

MHA opposed the bill on the grounds that religious protections and exemptions already exist for individuals working within the healthcare setting, and that the broad scope and vagueness of the bill could threaten the safe and nondiscriminatory delivery of patient care.

## REVISE COMMUNITY BENEFIT LAWS FOR NONPROFIT HOSPITALS HB 509 WAXCE

HB 509 would require nonprofit hospitals to provide free care to patients with family income at or below 300% of the Federal Poverty Level (FPL) while requiring discounted care up to 500% of FPL. In addition, it specifies that 50% of a hospital's subsidized health services shall be spent directly providing mental health services on an individual basis. The bill also provided language for additional penalties for failure to meet the community benefit standards.

## HB 708 ESTABLISH GOVERNANCE REQUIREMENTS FOR NONPROFIT HOSPITALS

HB 708 would add requirements for nonprofit hospital boards, including: must live in the county of, or in an adjacent county to, the hospital; cannot be an employee of the hospital; and must not have donated more than \$5,000 to the hospital in the previous five years. The bill also outlined other criteria the board must meet.

## SB 308 ESTABLISH PATIENT VISITATION RIGHTS

SB 308 states a patient has a right to a minimum of two hours of in-person visitation per day and, subject to clinical and safety restrictions, visitation may not be limited to one visitor per day. This bill would prohibit a care facility, Montana DPHHS or the governor (including during a state of emergency or disaster declared by the governor) from terminating, suspending, or waiving patient visitation rights.

A care facility may, consistent with the precautions required to be taken by staff and other personnel: (a) require a visitor to submit to health screenings necessary to prevent the spread of infectious diseases; (b) restrict a visitor who does not pass health screening requirements; (c) require a visitor to adhere to infection control procedures, including wearing personal protective equipment; and (d) limit the number of persons in a room at one time pursuant to occupancy laws.

The bill also prohibits a care facility from restricting visitation based on vaccination status.

## SB 364



# SB 364 would mandate that hospitals do not charge a patient or payer (insurer) more than 250% of Medicare rates. The bill was amended to add language to would require hospitals to provide additional reporting on how private reimbursement compares to Medicare reimbursement and also impose a state penalty if hospitals are not in compliance with federal price transparency requirements.

The bill was amended several times through the process, evolving from a bill at first focused on capping charges to one focused on reporting data already publicly available or already reported to the State.



## HB 665 REVISE LAWS RELATED TO INSURANCE COVERAGE OF BREAST EXAMINATIONS

HB 665 would ensure patients receiving mammogram care receive coverage for "minimum mammography" and other breast diagnostics as directed by their medical provider, especially in those cases when additional care is required (such as a diagnostic mammogram, breast MRI or ultrasound). A minimum payment of \$70 for "minimum mammography" would include other breast diagnostics as needed, and is designed to encourage patients to obtain their mammograms on a regular basis per the standard of care.

## SB 223 ESTABLISH REQUIREMENTS FOR INSURANCE COVERAGE OF CLINICIAN-ADMINISTERED DRUGS

SB 223 would prohibit health insurance companies from refusing to authorize, approve or pay a participating provider for providing covered clinician-administered drugs and related services to covered persons. This would allow the insured individual to choose their pharmacy instead of the health insurer requiring insured individuals to use a third-party specialty pharmacy contracted by the insurance company.

## **HB 828** AUTHORIZE AN AMBULANCE PROVIDER ASSESSMENT PROGRAM

HB 828 would implement an ambulance provider assessment on ground ambulance, including for a municipal fire or police department or other government entity. The bill originally excluded hospitals included in the current hospital utilization fee program but was later amended to allow hospitals to participate. MHA has been unable to perform any financial analysis due to lack of data. The impact on members is unknown.

## HOMES

HB 891 would provide a one-time appropriation to stabilize nursing homes with the money to be paid out in State Fiscal Year 2022. The bill originally provided \$41 million but was later amended to provide \$5 million. The stabilization payments would be prioritized for nursing homes more than 60 miles away from another nursing home or in those areas where hospitals have a backlog of patients who are unable to transition to a nursing home because of capacity issues.

## HB 206 GENERALLY REVISE MILL LEVY ELECTION LAWS

## HB 409 ADOPT ADVANCED PRACTICE NURSE COMPACT

HB 409 is specific to Advance Practice Registered Nurses (APRNs) allowing a multi-state license for those APRNs with an unencumbered license.

## HB 448 REVISE LAWS RELATED TO RIGHT TO WORK

It would be unlawful for a labor organization and an employer to enter into a contract or agreement that requires the employee to pay dues, fees, assessments or other charges of any kind to a labor organization as a condition of obtaining or retaining a job. Additionally, an employer may not discharge or otherwise discriminate against an employee because of the employee's refusal to join or pay dues, fees, assessments or other charges of any kind to a labor organization.

HB 448 also defined the right of public employees to both self-organize as well as the right to not join a union.

## HB 568 ESTABLISH SAFE NURSING STANDARDS FOR HOSPITALS

The bill included corrective action and penalties for hospitals that failed to comply with the staffing plan.
