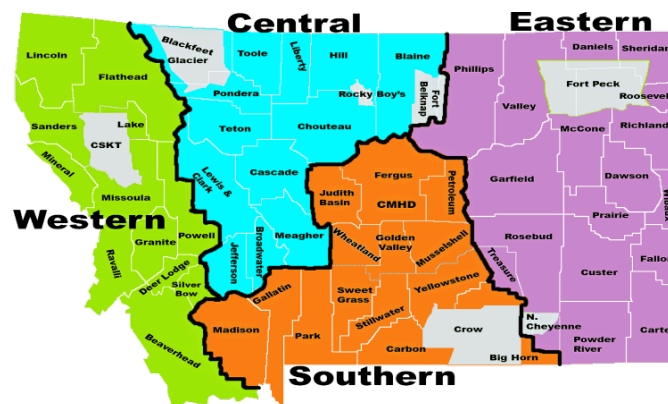


Our Mission

What We Do

Planning: We develop and maintain regional emergency operations plans, cooperative agreements, and annexes related to chemical, burn, radiological, nuclear, pediatric, highly infectious disease surge scenarios.

Training: We coordinate and deliver trainings available to all RHCC members that count toward continuing education (CE) credit hours and advance emergency preparedness and response capabilities.

Exercising: We design and conduct regional exercises that test response capabilities related to medical surge, patient movement, and cybersecurity and non-cyber extended downtime impacts.

Montana Healthcare Mutual Aid System (MHMAS)

MHMAS is the Emergency System for the Advance Registration of Volunteer Health Professionals (ESAR-VHP) for the state of Montana. MHMAS is a secure, web based online registration system used to register, verify, and credential volunteer health care professionals BEFORE a major disaster or public health emergency occurs.

Juvaré Platform

The following Juvaré products are paid for and maintained by DPHHS Hospital Preparedness Program (HPP), Public Health Emergency Preparedness, MHA, and the Health Care Coalitions to support local health care organizations and communities during both normal operations and emergencies.

Bed Availability and Resource Tracking

EMResource - An emergency resource management system designed for health care providers and first responders to track asset availability, and facility operations. EMResource gives a comprehensive view of local, state, and regional resources.

Real-Time Incident Management

eICS - Plan for, respond to and recover from incident with a prepared incident command system for all-scale events with a robust toolkit that is easily customizable to fit unique situations.

Volunteer Management

CORES RMS - Fast, secure volunteer information. Volunteer management, real-time alerts, and ESAR-VHP compliance.
